



# TIRANA CONNECTIVITY FORUM 29 - 31 October 2019



The objective of the 5th edition of Tirana Connectivity Forum (TCF19), will be twofold. First it will take stock of the progress made in the Connectivity Agenda with focus on energy, transport, and on people-to-people connectivity. Since the Summit of Vienna in 2015 and the endorsement of the first connectivity projects, project implementation has substantially advanced, while new infrastructure projects have entered the pipeline. As a result, their impact is becoming visible at the same time as new challenges inherent of implementation phase are appearing. Moreover, regional institutional cooperation is showing strains as illustrated by the gap between transposition and implementation. People-to-people component has successfully gone through the "inception phase" – the youth exchanges are becoming the new normal.

However, two external factors are directly impacting connectivity in the Western Balkans (WB6): intra-EU developments such as the rise of populism and Brexit; and the decoupling of global supply chains and the increasing pressures that it puts on globalization. While WB6 region is promoted as an optimal FDI destination, geopolitics is interfering with economics to decide the new value chains or the Balkan countries trade patterns. The slowing down of EU Enlargement has exposed the fragility of deep-cutting reforms engaged by the WB6 institutions, catching those very institutions in the middle of their transformation into well-governed ones.

October 30th panels will cover the Connectivity Agenda spatial component: i.e. energy and transport, as well as p2p. In the energy panel, after the presentation of the achievements in energy infrastructure, the debates will focus on regional institutional cooperation, geopolitics and energy security implications, and on Balkan countries challenges impacting the flow between transposition and implementation of legislative framework.

The transport panel will provide an overview of the implementation of transport projects under the Connectivity Agenda, complemented with the challenges they are meeting during their implementation. Special focus will be given to the local institutional context and of their role in all the phases of project cycle i.e. planning, construction and operations.

Youth exchanges and migration flows will be the subject of the **p2p** panel discussions. The increasing number of youngsters visiting the neighbor countries and their immersion in neighbors' cultures are the biggest investment for the European future of the region. However many individuals are cutting short their journey to EU by migrating. This phenomenon, which is affecting especially the middle class, is depriving Balkan countries from their best and dynamic part, as well as damaging the functioning of local democracy.

In October 31st, TCF19 will put the connectivity in the larger WB6 context by analyzing its interaction with geopolitics and the deep-cutting reforms engaged in the region in the view of EU membership. After taking stock of the current achievements and upcoming challenges of the Western Balkans for 2020, the participants will focus on region's integration dynamics, consequences of de-globalization and the future scenarios.

As a multi-layered phenomenon, connectivity offers a unique view of the inter-linking between infrastructure projects and the context in which they are implemented. In the panel connectivity and **geopolitics**, special attention will be paid to emerging patterns of supply chains in the WB6 countries, to the dynamics of regional trade conflicts, as well on the importance that better connectivity has for anchoring the WB6 to EU.

The last panel will focus on regional connectivity and its inter-relations with the deep-cutting institutional reforms engaged in WB6. Being "well governed" is a very important transition quality that makes possible an increased institutional efficiency, bigger impact and secured sustainability of any investment in the adoption of Copenhagen Criteria. In an ever changing environment, stronger relations between WB6 and European institutions, increased peer-to-peer scrutiny, sector integration, involvement of WB6 peers to selected EU fora, higher and better inclusiveness, or conditionality based on integrity compliance require an institutionalized connectivity between European and WB6 institutions.

What will be the role of Berlin Process from 2020? How better connectivity can solidify the WB6 achievements during those 25 years, as well as push the Enlargement agenda? The Poznan Summit while underlining the importance of spatial connectivity for WB6 to catch up with EU peers, also recognized the many challenges met during implementation, and especially the role and capacity of local institutions. Planned stock-taking events in Sarajevo and Pristina illustrate the need for intense coordination between WB6. The binary organization by Bulgaria and North Macedonia of 2020 WBS is an opportunity to shift the connectivity vantage point towards Western Balkans.

The event has now become an annual benchmark for experts, researchers, academicians, CSO and policy-makers involved in EU Enlargement in WB6, in Regional Cooperation, and Connectivity dynamics.

# SPEAKERS | As per appearance in the Agenda



Dr. Klaus Fiesinger is regional director for Southeast Europe of the Hanns Seidel Foundation. In this function, he is responsible for promoting the European idea, international dialogue, cross-border cooperation, political culture and civic education in new EU member states, candidate countries as well as potential candidate countries. Since 1992, he has been head of the Division for Central, East and Southeast Europe and Central Asia at the Hanns Seidel Foundation in Munich. Furthermore, Dr. Fiesinger is member of IDM, the Austrian Institute in Vienna for the Danube Zone and Central Europe as well as of "Südosteuropa Gesellschaft". Dr. Fiesinger received his Ph.D. in political science from the University of Munich. He is author of the book "Ballhausplatz - Diplomatie 1945-1949." From 2004 until 2012, he was visiting professor at the Andrassy University in Budapest. Occasionally he gives lectures on Euro-regions, cross-border police cooperation and political education.



Krisela Hackaj is since 2011 Director of the Cooperation and Development Institute, an Albanian independent Think Tank organization that focuses on research in regional cooperation, economic and social development dynamics and institutional governance. Her professional expertise covers EU cross border cooperation programmes and projects, national strategic framework monitoring and budgeting, and regional cooperation. Her main research topics relate to EU Integration process, regional cooperation, connectivity agenda and youth in the Western Balkans. She graduated in "Public Administration and International Organizations" at Bocconi University and holds a Master Degree in "International Career and International and European Institutions" from University of Parma.



Wieslaw Tarka is Ambassador ad personam at the European Policy Department and was the Coordinator of the Western Balkan Summit at the Ministry for Foreign Affairs in Poland. During 2015-2018, Mr. Tarka served as Poland's Ambassador to Sweden, whereas during 2012-2017 he was Director of the Foreign Service Inspectorate at the Ministry of Foreign Affairs. Other positions include that of Poland's Ambassador to Croatia, office at the Polish Embassy in Stockholm, Undersecretary of State at the Ministry of Interior and Administration and as Deputy Director of Warsaw City Hall. During 2005-2007 he has been chair of Polish Part of Cross-Border Cooperation Committees and is now Chair of the Interministerial Committee of the Outer Border Management Task Group. Mr. Tarka has concluded his studies at the University of Warsaw.



Daniela Boudinova is the special Coordinator for the Berlin Process Summit 2020 in Bulgaria. Her professional experiences include: Deputy Head of Mission, Embassy of Bulgaria in Skopje Brussels (NATO), Vienna (OSCE and UN) and Madrid Head of the OSCE and Regional Security Department, MFA - Bulgaria National Point of Contact to the EU Working Party on the OSCE and the Council of Europe Desk officer for Regional and International Security (arms control, non-proliferation, disarmament). National Point of Contact to the EU CONOP and COARM Working Parties, NPT, IAEA, CTBT Head of Unit at the European Integration Directorate, MFA - Bulgaria Chief of Staff of the Bulgarian Chairmanship of the OSCE (2004) – Vienna EU Chef de File for Albania at the OSCE - Vienna Lecturer at the MFA Diplomatic Institute and Sofia Security Forum . She pursued her PhD Research at the University of Corsica, France and her MA of European Studies from the College of Europe – Bruges, Belgium. She also has a MA of French and English Philology from the State University of Sofia, Bulgaria George C. Marshall Centre of Security Studies' Alumni.



Dr. Florensa Haxhi holds the position of the Director General of the Development Programs and Cooperation Unit, at the Prime Minister's Office in Albania, and is responsible of drafting a number of national development programs in different sectors which are translated into concrete executable national strategic projects with a direct impact to the country's economic growth. The last 2 years, she has also been the Program Manager of the Regional Economic Area, focused on the development of the WB region with the aim at developing an economic area where goods, services, people and knowledge move without borders. She is responsible for coordinating work with the relevant national and regional stakeholders involved, ensure a successful implementation of measures under the Multi-annual Action Plan and contribute towards the drafting and signing of regional agreements. She has earned a PhD Degree in Economics (Public Administration focus) from the state university in Albania; owns a Bachelor of Science in Business Administration and Finance (dual major) from the State University of New York and an MBA in International Finance from Ecole Superieur de Gestion (Paris Graduate School of Management).



Frank Hantke owns a Master in Mechanics, German Language, Pedagogic (Teacher for Vocational Training) in 1983. Later, Mr. Hantke served as the Head of Department, Strategic Issues, HQ of German Trade Union Confederation (DGB) for the period from 1987 to 1989. During 1995 – 1998, he was the Head of Department for International Relations at DGB/Since 1998, Mr. Hantke has been an expatriate for Friedrich-Ebert-Stiftung (FES) in the following regions and countires: CEE, Poland, SEE, Serbia, (both regional); Country Director Afghanistan, Albania, Kosovo, Macedonia – recently since 2017 Kosovo, before 2012 – 2017 Albania. Since 1974, Mr. Hantke is a member of IGM (Metal-Union), later IG BCE (Mining and Chemistry Union) and since 1976 a member of SPD (Social Democratic Party of Germany).

She specialises in the EU and NATO Integration of the Western Balkans, the social and political transformation of the Balkan States, civil society development in post-communist and post-conflict societies. She has collaborated with various Polish state institutions, the Schuman Foundation, the Friedrich Ebert Foundation and think tanks from the Western Balkans. She is a guest lecturer at the University of Warsaw, the Diplomatic Academy and the College of Europe in Natolin. Marta Szpala coordinates main activities of the related to the organisation of experts' meetings in the framework of Western Balkans Summit in Poznań.



Meliha Muherina holds a degree in International Relations from Faculty of Social Sciences, Ljubljana. She is a Project Manager at Centre for European Perspective (CEP) in Slovenia, where she is working on regional development projects in the Western Balkans. CEP is responsible for management of official international development assistance projects by the Republic of Slovenia. She is also part of organizing team of Bled Strategic Forum, one of the leading political conferences in the region, where she is part of the team as a Programme Director of Young Bled Strategic Forum. Apart from that, Meliha also has extensive experience in research and dissemination for H2020 projects.



Ardian Hackaj is the Director of Research at Cooperation and Development Institute – an independent Tirana-based think tank. He has authored research works on the Berlin Process, on youth, migration, connectivity and Belt & Road Initiative in the Western Balkans. During his career, Mr. Hackaj has held management positions at the College of Europe-Bruges, International Organization for Migration, United Nations, and the EU Commission. He holds an MA from College of Europe, a BA in International Economics from Université Lumière, Lyon II, and a University Diploma in European Studies from Institut d'Etudes Politiques, Lyon.



Stine Klapper heads the office of the Friedrich-Ebert-Stiftung (FES) in Tirana. Previously, she managed the FES offices in Bangkok and Skopje and worked at the foundation's Prague office. Prior to joining FES she was Research Associate at Freie Universität Berlin. She studied International Relations and European Studies in Berlin, New York and Osnabrück.



Since July 2019 Dr. Tobias Rüettershoff is the Director of the Konrad-Adenauer-Stiftung (KAS) office in Albania. Previously, he was a speaker for East Central Europe in the team Europe / North America. From June 2015 to March 2017 he worked as a desk officer in the Team Domestic Programs, at the Department for European and International Cooperation at Konrad-Adenauer-Stiftung (KAS) in Germany. Mr. Rüettershoff is a former KAS scholar and studied Political Science, Public Law and International Relations in Mannheim, Maastricht and Sheffield before earning his doctorate at the University of Exeter on US Security Policy. Before joining KAS, Dr. Tobias Rüettershoff was an intern at the German Bundestag, in the center Innere Führung der Bundeswehr and as research assistant at the University of Oxford.



Since January 2019, Mrs. Belinda Balluku is the Minister of Infrastructure and Energy of Albania. Mrs. Balluku, before her appointment as Minister of Infrastructure and Energy, from September 2013 held the position of Director General at ALBCONTROL JSC, the Air Navigation Services Provider of Albania. Mrs. Balluku has extensive experience in the field of telecommunication, starting from November 2000. Mrs. Balluku has held senior management positions initially as Customer Care Director where she first created the Call Center service in Albania and soon after became Director of Marketing. In 2004, Mrs. Balluku joined the staff of the Municipality of Tirana, initially as Public Relations Advisor and later as the Head of the Mayor's Cabinet. Since 2006, Mrs. Balluku has been a vital part of the Socialist Party. She has participated in election staff, has organized important political events and has served as the Head of the Mayors' Cabinet during Jan. 2011 - Jan. 2012.



Since September 2018, H.E Luigi Soreca is the EU Ambassador, Head of the European Delegation to Albania. Prior to this appointment, Mr Soreca was Director for Security in DG HOME of the European Commission, with responsibilities in the fight against terrorism and radicalisation, organised crime, drug trafficking, corruption and cybercrime. He was in charge of the EU support for law enforcement cooperation at European and international level, and Member of the Management Board EUROPOL, CEPOL (police training) and EMCCDA (European Monitoring Centre for Drugs and Drug Addiction). In the Juncker Commission, he coordinated the services' efforts for the preparation, adoption and implementation of the European Agenda on Security in April 2015. During the terrorist events in 2015-2017 in the EU, from this position, he has coordinated the EU policy response to the attacks in terms of new legislative and policy initiatives, including the preparation and adoption of the Directives on Terrorism, Firearms and Money Laundering, the Action Plan on Firearms and Explosives and the creation of the EU Counter-Terrorism Centre at EUROPOL. Luigi Soreca has overseen the work of the Radicalisation Awareness Network (RAN) and was the Chair of the EU Internet Forum. In the area of drugs trafficking, he was also responsible for the EU Action Plan on drugs trafficking for 2017-2020. He was the Commission representative in the G7 Senior Officials "Rome-Lyon" Group, which deals with global terrorism and transnational organised crime. He also negotiated several international agreements on behalf of the EU with third countries, including with the USA on PNR and TFTP. During the migration crisis in summer 2016, he was appointed as Special Commission Envoy to Italy for the launch of the relocation process under Council Decision 2015/1523.



Mrs. Majlinda Bregu is an accomplished Albanian Politician, a strong EU believer, and a promoter of women's rights and empowerment. She also has a prominent career as university professor and journalist. Mrs. Bregu was elected as a Member of Parliament for three consecutive legislatures, (2005-2017) as a Democratic Party member. From March 2007 to September 2013, she served as Minister of European Integration and the Government Spoke-person. Both duties, which she passionately accomplished, allowed her to domestically steer the increasing challenges of European Integration membership and promote abroad the importance of the membership perspective for the stability of the region. During 2013 – 2017, Mrs. Bregu chaired the European Integration Committee at Albanian Parliament and the National Council for European Integration. In her parliamentary career, she was consistently working for an all-inclusive approach and farreaching consensus on the European perspective of Albania and the region. Additionally, she has actively supported and contributed to the civil society forum established under Berlin process. As from April 2018, Mrs. Bregu is appointed as the Secretary General of the Regional Cooperation Council, the operational arm of the South-East Europe Cooperation Process, which mission is to sustain focused in the regional cooperation in South Eastern Europe through a regionally owned and led framework that also supports European and Euro-Atlantic integration.



David M. Gould is currently Lead Economist and Program Leader in the East Asia and Pacific (EAP) Region of the World Bank. David is the author of several books and peer reviewed journal articles on International Trade and Finance, Migration, and Economic Policy. Currently, he is leading a study on the development impacts of technology as well as developing a blockchain application to support peer-to-peer risk mitigation in agriculture. During his past 16 years at the World Bank, he has led teams to deliver country development strategies and analytical and lending operations in Latin American, Europe, Central Asia, and South Asia. He holds a Ph.D. in International Economics from UCLA and is a Chartered Financial Analyst (CFA) charter holder. Prior to the World Bank, David served as the Director of Global Economic Analysis at the Institute of International Finance and Senior Economist and Policy Advisor at the US Federal Reserve. He has held visiting research positions at the Central Banks of Mexico and Chile.



Besnik Leskaj is the Chief Executive Officer and one of the Founding Partners of Abkons. He built and developed Abkons in 2005 and turned it into one of the most successful multidisciplinary consultancies in Albania and Western Balkans. He oversees all areas of strategic planning, market assessment, public finance management, project management, institutional assessment and capacity building. He has acted project director for the Trans Adriatic Pipeline project, leading planning and execution and creating a framework for the first Land Compensation Study in Albania. He offers his regional expertise to various public and private entities, serving as an advisor for local business and sustainable development initiatives.
